Course Provisions

Safeway Driving Incorporated will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the-wheel (BTW) instruction, and 4 hours of observation time, Safeway Driving, Inc. will conduct the behind-the-wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed.

Notice: This provider is required to be certified by the Secretary of State. If you have any complaint, which you cannot settle with this provider, write: Michigan Department of State, Driver Programs Division, Lansing, MI 48918. Completion of driver education instruction does not guarantee qualification for a driver license.

Terms

1. The student must be at least 14 years/8 months of age by the first scheduled day of class (verified by a birth certificate required)
2. The parent or guardian agrees to pay the amount of \$435. (\$100 deposit on the website with balance due the first day of class, cash or check only)
3. Requirements to pass the course: show up and participate in all classroom and driving activities, complete all homework assignments, pass the test with minimum of 70%.
4. The required score to pass the 80 question State Test is 70% or higher. A total of 3 attempts will be given to pass the test if needed.
5. The cost of materials and supplies for the class is included in the fee, however if you lose the book there is a \$35.00 fee. There is a \$25 Lost certificate fee.
6. Driving appointment cancellation or no show, there is a reschedule fee of \$40 for each missed drive.
7. There will be one classroom make-up day, no more than one absence is allowed. Students will be required to write a 2-page paper on “the aspects of defensive driving” if class is missed! If school is canceled due to weather, classroom and drives will be rescheduled.
8. Cell phone use during class and driving activities is strictly prohibited and will be grounds for failure! Please discuss with the instructor any emergencies in advance.

Refund Policy

Before the third-class period a full refund, less the deposit, will be given if requested. After the third-class period there will be no refunds! If you withdraw from the course or miss more than one class date, for any reason, you will be dropped from the class with no refund!

BTW WAIVER
